**APPLICATION** – to begin the process. Use application form COM-A1 for the Licensure process, and application form COM-A2 for the Ordination processes.

## **REQUIREMENTS FOR RECOGNITION OF LICENSURE PRIOR TO ORDINATION – for**

persons in the process of completing their educational requirements for Ordination, expecting to enter the professional ministry of the American Baptist Churches.

## **REQUIREMENTS FOR RECOGNITION OF ORDINATION, STANDARD PROCESS AND**

**NON-STANDARD PROCESS** – (1) for persons who have been licensed, have met the educational requirements, have met all ABCOPAD requirements, and have received a call to ministry in the American Baptist Churches (Standard Process); and (2) for persons who have been licensed, have <u>not</u> meet full educational requirements, but have met all ABCOPAD requirements, and have met Ministry Plan requirements (Non-standard Process).

**REQUIREMENTS FOR RECOGNITION OF PREVIOUS ORDINATION** – for persons Ordained outside the American Baptist Churches, desiring to enter the American Baptist ministry. See checklist form COM-CL7.

**REQUIREMENTS FOR RECOGNITION OF CERTIFIED LAY MINISTER** – for lay persons who have completed the Certified Lay Minister track through the Church Leadership Institute, have recognized the distinct call of God to church leadership.

**MENTORING** – persons appointed by the Commission on Ministerial Leadership to assist candidates through the Licensure and/or Ordination process.

**PERSONAL REFERENCE FORMS** – sent by the applicant to five persons providing personal references for his/her application for Recognition of Ordination. Use form COM-PR.

**REPORT FORMS** – used to report to the ABCOPAD Commission on Ministerial Leadership those licensures, examinations, and ordinations that have been completed.
